WE IMPLEMENTED THE USE OF OUR NEW WALK BEHIND GREENSMOWERS AND NOTICED A MUCH IMPROVED PUTTING SURFACE ON OUR GREENS. COURSE CONDITIONS WERE BY ALL ACCOUNTS THE BEST THEY HAVE EVER BEEN THROUGHOUT THE SUMMER. PALMER GOLF COURSE MADE *GOLF DIGEST'S* "BEST IN STATE" LIST FOR THE SIXTH CONSECUTIVE YEAR.

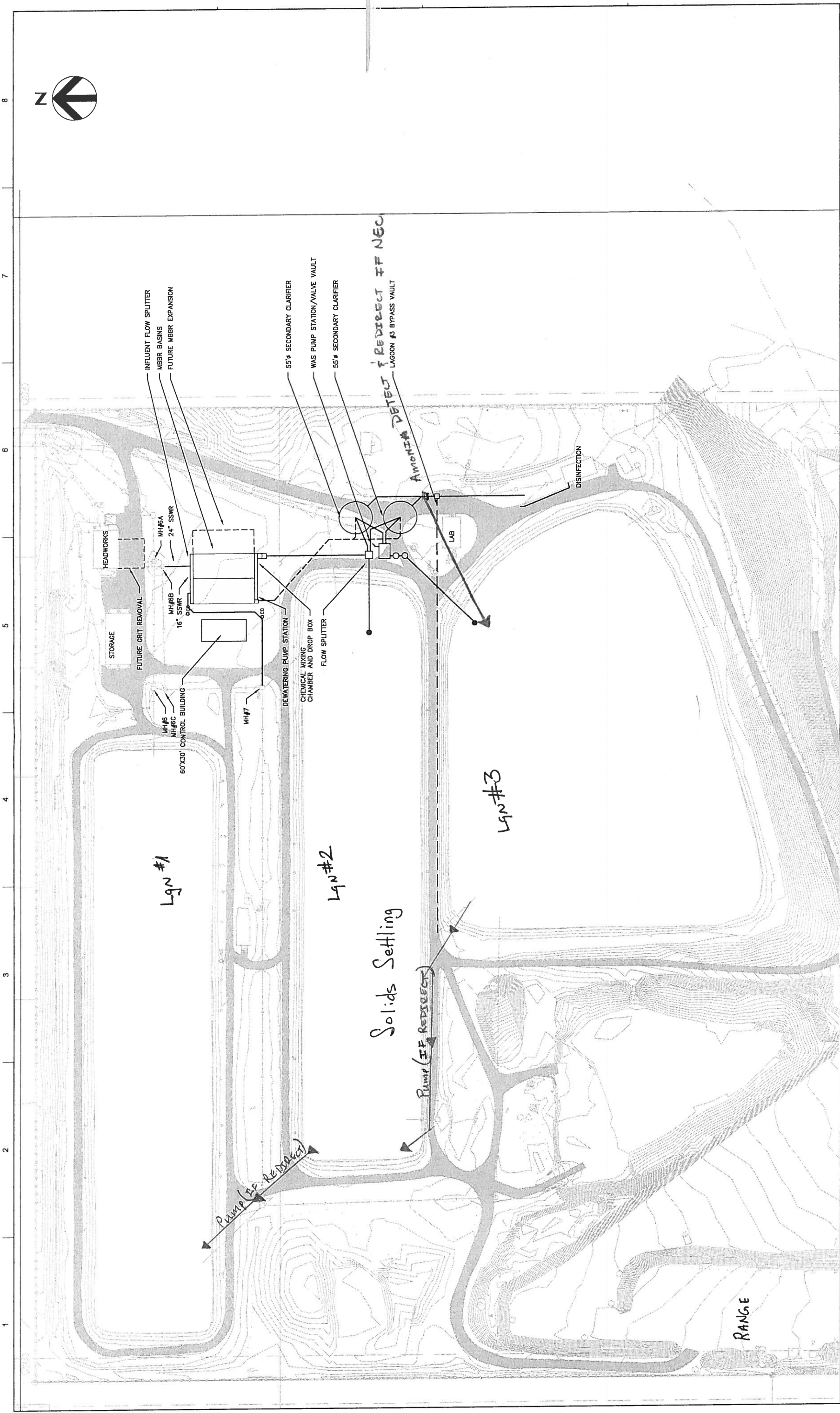
