

## **PALMER POLICE PRESS RELEASES FOR** **July 15-21, 2024**

On July 15, 2024, Palmer Police arrested MARY M. MULLIGAN, age 23 of Wasilla, on a felony warrant for Forgery 2 and Theft 2. She was remanded to the Matsu Pretrial Facility and her bail was set at \$250.00 per the warrant.
