

## **PALMER POLICE PRESS RELEASES FOR** **July 8-14, 2024**

On July 10, 2024, Palmer Police arrested CHAD M. RIDER, age 34 of Anchorage, for two counts of Violating Conditions of Release from original charges of Operating Under the Influence, Misconduct Involving Controlled Substances, and Violating Conditions of Release. He was remanded to Mat-Su Pretrial and held without bail.
