

PALMER POLICE PRESS RELEASES FOR
August 5-11, 2024

On August 5, 2024, Palmer Police arrested JEREMY L. CASEY, age 47 of Palmer, for Assault in the Fourth Degree and a Parole Violation on the original charges of Burglary in the First Degree and Vehicle Theft in the First Degree. He was remanded to Mat-Su Pretrial without bail for the Parole Violation and \$500.00 cash/performance bail for the Assault in the Fourth Degree, per the bail schedule.

On August 5, 2024, Palmer Police arrested JAMES B. OLIVERI, age 35 of Wasilla, on two warrants for Fail to Appear for Pretrial Conference Hearings on original charges of Violating Conditions of Release and Misconduct Involving Controlled Substances 5th degree. He was remanded to the Matsu Pretrial Facility. His bail was set at \$500.00 per the warrants.
