

## **PALMER POLICE PRESS RELEASES FOR** **August 12-18, 2024**

On August 14, 2024, Palmer Police arrested MAXIM A. KOZAREZ, age 22 of Palmer, for DV Assault in the Fourth Degree. He was remanded to Mat-Su Pretrial without bail, per the bail schedule.
