

**PALMER POLICE PRESS RELEASES FOR**  
**August 19-25, 2024**

On August 19<sup>th</sup>, 2024, Palmer Police summonsed JORDAN A. BAHR, age 22 of Palmer, for the charge of Driving Under the Influence. BAHR was given a summons with a court date and released.
